I heard about the revision from Steffen Pölzel on Friday , 05-24-2024, as I was on vacation last week. He covered the inital surgery on Wednesday, 05-22-2024. This went without any problems. He heard from Dr. Sayed by phone that the patient had nerve irritation immediatly after the surgery. They did a CT. The second implant protruded a little into the foramen. Dr. Sayed wanted to revise the implant independently on Saturday , 05-25-2024.
