Dr. Vasilakis performed a Granite case on 2/11/25 at Marietta Memorial Hospital where he implanted bilateral (1 on each side) 70mm x 10.5mm Granite implants. When he attempted to advance the 70mm Granite on the right SI joint, the implant would angulate at the tulip head when it met resistance. This caused the implant to skive off of the trajectory. This kept occurring even after reengaging on the Navigated Driver and re-tightening. Eventually, a new 70mm x 10.5mm Granite implant was opened and there was no issues with the new one.
